## **Selected Non-compliance Cases of Hong Kong Companies**

The Hong Kong Companies Ordinance (Cap. 622) requires a Hong Kong limited company and its officers (including directors, company secretaries and managers) to comply with certain requirements. The Registrar of Companies of Hong Kong may take prosecution action against companies and each responsible person for offences under the Companies Ordinance. Under the Companies Ordinance, a responsible person includes a company's officers or shadow directors who authorizes, permits or participates in the failure or contravention committed by the company (in the case that the company's officers or shadow directors are body corporate, such body corporate's officers or shadow directors are included).

Specifically, if a company commits minor regulatory offences under the Companies Ordinance, it may be liable to a certain amount of fine upon conviction (generally including a fine for the breach of the relevant section(s) of the Companies Ordinance and a late fine for each day of delay in delivery); if the company commits more serious regulatory offences under the Companies Ordinance, not only may a fine be imposed, but the responsible person may also face imprisonment. The Companies Registry said that in general, penalties imposed on public companies and listed companies would be more severe than on private companies. Therefore, public companies and listed companies should be more cautious about this.

According to statistics released by the Hong Kong Companies Registry, the total number of summonses issued by the Companies Registry as at November 2019 was 4,397, with a total fine of HK \$14,187,520. It can be seen that the number of enforcement cases is by no means insignificant in Hong Kong, to which the companies are advised to pay close attention. We have extracted some of the typical cases during 2015-2019 from the prosecution cases published by the Hong Kong Companies Registry for the companies' reference with a view to avoiding contraventions.

As can be seen from the above cases, the common irregularities in Hong Kong companies include failure to keep the relevant registers in the registered offices of the company, failure to comply with the requirements for the preparation and filing of annual returns, failure to hold annual general meetings, failure to have a registered office in Hong Kong, and knowingly or recklessly making misleading, false or deceptive statements, etc. The Hong Kong Companies Registry has always maintained a strict and impartial attitude towards contravening companies and their responsible persons. In this regard, companies are urged to raise their awareness and carefully examine their internal compliance so as to ensure full and strict compliance with the regulatory requirements.
